Make language and labels clearer on ILP for "mandatory trainings" and make it easier for users to find the trainings required for their program.


Recommendation:

     for licensing






## SPARK Resources on Indiana Learning Paths

- This includes all Paths to QUALITY Support Tools



## Old Business – Fingerprinting Recommendations

Include the following in the SPARK fingerprinting resource: information about approved vendors; information about why fingerprinting is required, especially for school-based programs.

A first draft of the resource has been shared with Regional Advisory Council Members and feedback gathered. Our Compliance & Operations Specialist is embedding that feedback with more information from OECOSL before publishing in MSLL.



#### Old Business – My SPARK Learning Lab Recommendations

Look into logistical changes that could be made that would allow users to move between the platforms (ILP, I-LEAD, My SPARK Learning Lab) without logging in and out.

This is not possible due to the limitations of the I-LEAD, Indiana Learning Paths, and My SPARK Learning Lab integration.

Explore ways to make the knowledge articles more accessible and streamline navigation.

SPARK is working with our Salesforce implementation partner, Venture Tech Group, on an on-going basis to continually improve the user's My SPARK Learning Lab and I-SAT experience. This is a topic of a conversation for our enhancement and would not be scheduled for release until June 2021.



#### Old Business - COVID-19 Related Recommendations

There is a need for further guidance for programs related to how long staff and children should quarantine after being exposed to, or testing positive for, COVID-19. The RAC asked SPARK to follow-up on this need by either creating guidance or sharing this need with other relevant partners.

SPARK continues to promote the guidance provided by OECOSL. The most recent update is as of 12/11/2020 and can be found on the OECOSL website at the bottom of the page.






#### **Case Resolution Statistics**




