# Old Business – Engagement Strategies

SPARK will craft a survey or focus group for former RAC members to understand their participation habits.

# Old Business – SPARK Annual Report

RAC members recommend that SPARK continue to connect the data to programs not participating and provide ways for RAC members to support both SPARK and providers.

SPARK is working with Jennifer Myers, RAC member, to advance identified programs in PTQ and create targeted learning opportunities for programs that have and have not submitted Stabilization grant applications. How can we engage RAC members to better support SPARK?



# Old Business – SPARK Salesforce

RAC members requested that SPARK track and utilize salesforce system to understand the county-level insights.

SPARK is still exploring our ability to provide county level data. There are some limitations due to the data that comes from I-LEAD. We are working with OECOSL to close these gaps in the future data system.

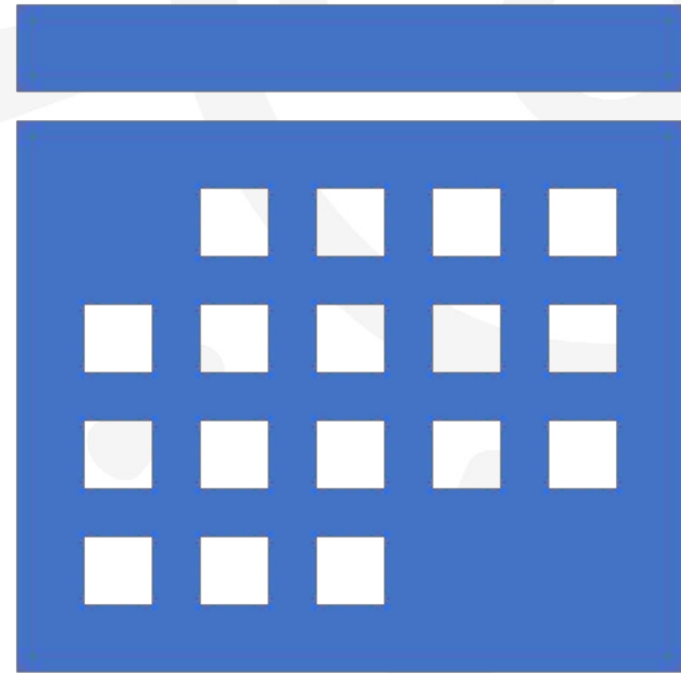
